FROM THE HEADTEACHER

In my final report to Governors at the end of the last academic year I suggested that, when we look back at this time in years to come, we may consider that Chew Valley School has enjoyed a kind of 'golden age'. It was with particular reference to the retirements of Mrs Sanders and Mr Hack who, between them, had served the school for more than sixty years. Their dedicated service to the young people of the Chew Valley over three decades is an inspiration on which I and my staff continue to draw.

The greatest achievement in the school over the year has undoubtedly been the completion of the Sixth Form and Community Building which was formally opened by John Hack last month. It represents the culmination of a shared vision between school and parents which recognises that the Sixth Form is of critical strategic importance for the success and reputation of the school. The fund-raising efforts of parents, staff and pupils together with the assistance of governors and the financial contribution of the Local Authority enabled the vision to be translated into reality. In particular I want to pay tribute to Rob Bradley, a former parent and governor, who has continued to provide consultancy to the school without charge. Without his guidance and professional support, I doubt whether the project could have happened either so quickly or efficiently or indeed within the straitened budget we had. The building is a pleasure to work in.

Although it seems a long time ago, the other significant landmark of the year was the Ofsted Inspection in December 2008. The inspection was extremely brief - on a 'reduced tariff' because of the ongoing success of the school – and confirmed the judgement that in all things the school was at least Good and in the majority of aspects is Outstanding. It goes without saying that we continue to work at the merely good! It is my profound wish that 09/10 will see us building on 'golden times' for an even more successful future.

GOVERNORS' ACTIVITIES 2008-2009

Much of the work of Governors is done through the sub-committees which report to the Full Board.

In Curriculum and Pupils committee over the last year we have reviewed school policies in relation to assessment, equal opportunities, child protection, drugs, behaviour and Special Educational Needs. We have monitored examination performance and also conducted a review of school meals.

In Finance committee, as well as reviewing finance policies we have been developing a three year strategy to manage the school budget (as surpluses reduce) in anticipation of a likely reduction in Government spending in future years.

Property Committee has been dominated this year by the management of the construction phase of the new building for sixth form and community and a substantial refurbishment programme which has created three new classrooms, a new Drama Studio and a Diploma room.

Personnel Committee has reviewed the staffing structure for the school, performance management and pay arrangements.

Health and Safety Committee has received regular reports from the school's Health and Safety Staff Rep and the Facilities Manager. Regular monitoring visits by the Local Authority have provided helpful feed-back for ways in which we can continue to maintain our high safety standards and further raise the bar.

The full board of Governors meets seven times in the year. It receives reports from the sub-committees and from the Headteacher. It also receives an annual report from the School Improvement Partner who completes monitoring visits throughout the year. In these ways, Governors are able to assist the Headteacher and his senior team in setting the strategic direction of the school.

EXAMINATION RESULTS 2009

Achievements

- 52% of A Level results were graded A or B
- The average point score per student was a record 751.2
- These results put Chew Valley in the top ten per cent of Sixth Forms.

Policy

Chew Valley School is a fully comprehensive school with a non-selective admissions policy. We enter pupils of all abilities for examinations: our philosophy is that we are here to provide opportunities for students, not to massage examination results.

This Finance Report relates to the twelve months ending 31st March 2008. The figures are presented in the prescribed CFR (Consistent Financial Reporting) format. This format is designed to enable the government to collate statistics and make valid comparisons between schools.

Local Education Authority (LEA) funding for years 7 to 11 is allocated each financial year and is mainly dependent on pupil numbers. Funding for years 12 and 13 comes via the Learning and Skills Council (LSC) and is allocated over the academic year, according to the number of pupils successfully completing each course.

Standards Fund money is for expenditure directly related to raising standards. It is allocated in April but can be spent over 18 months.

Funding from the LEA rose by 4%, over the previous year. Overall income rose by 1.2% and expenditure 1.4%, reducing the carry forward balance by just under 20% on the previous year.

Capital income and expenditure relates mainly to the new Sixth Form and Community Centre which will be completed in the Summer of 2009.
