Last Year's Overview

We've had some very successful events with lots of helpers this year.

January's Bingo night was a huge hit — a sell out with a waiting list. Chrissie's introduction of a booking system on Eventbrite worked well for keeping tabs on numbers and also to drive up interest with people seeing how popular it was and wanting to be involved as well to the point that we had to run a waiting list for tickets. There was some concern that as people weren't pre paying we might have an issue with no shows but this didn't prove to be the case and the hall was packed (approx. 140 people).

This was followed in March with our annual Quiz which was also well attended and a lot of fun. There was room for more teams though so it would be great to try and make this a sell out this year too!

The **pre-loved uniform sales** continue to be a big earner for us.

We have done a few in person events with the Y7 induction evening being a very important one to encourage new parents to purchase all their uniform needs from us. It was so successful that we sold out of the smallest sizes and most of our Moreton and Hauteville stock. Curiously Rodney and Bilbie parents were less engaged!

We also held a stall at Harvest Home and sold nearly £300 of stock as well as raising the profile of what we are doing.

CD did some work with the Climate Action team early in the year to sort the stock and try an ordering system so that parents can also access items without having to come in person to events. The team also rang the uniform supplier in Wells to ask that they stop embroidering names onto PE kit as it makes it harder to pass on.

It has proved tricky to work regularly with the Climate Action group on this as they have so many projects on going but it did prove that there is a steady demand for items. Money has been invested in sturdy storage boxes and the site team have kindly provided us with a larger storage area that is much easier to access. Orders are regularly being emailed in and the level of donations has increased significantly as parents become more aware of the pre loved shop. The uniform section of the website has been updated to sign post parents to us. The ordering system has brought in well over £250 to date.

The 500 Club continues monthly and is a good regular fundraiser, efforts have been made to push signing up to the scheme at all events but more would be great so a continued focus on publicity to existing parents this year to increase numbers is still needed.

We've also continued to run bars at numerous school events throughout the year and it would be great if any members of the committee are keen to drive additional events.

Support To The School

In the last year we have supported a wide range of requests including:

Outdoor education equipment (compasses and tents), WW2 Workshop, SEN equipment, Enrichment week support, an Author visit and Maths, Geography and PSRE Text books.

We currently have a healthy balance of £19,000 in our account, so welcome more applications from the school in the coming year.

4. Treasurer's Report

We have had another successful year of fundraising with net income £12,209. 71 compared to £13,764.05 in 2023/24.

The 500 club remains our biggest earner at £2736 with 10k donations of £3,103.41.

The bingo night proved very popular with a net profit of £1,202.37.

Successful bids paid to the school were £15,823 compared to £19,167 in 2023/24.

We currently have reserves of £18,280.18 in the bank accounts.

Bids already agreed total £3,085

Ringfenced funds of: £477.56 for the Drama dept,

£243.86 Music dept and

£62.24 Library dept

£425.47 Marmion House

So funds available to spend currently are £13,986.34 before any more fundraising activities.

Recommend that we continue to push the bids in school to spend as much of the reserves as possible for the benefit of the students. A balance of £5k in reserve would be a recommendation.
